1 Respective responsibilities of the body and the auditor

2 External auditor report 2018/19

Except for the matters reported below on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return, in our opinion the information in Sections 1 and 2 of the Annual Governance and Accountability Return is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The Accounts and Audit Regulations require that the Authority retains copies of the Annual Governance and Accountability Return on a free to access website for 5 years (Paragraph 13.2). This requirement has not been met; however, the Council answered "yes" to Assertions 3 and 4 in Section 1 regarding compliance with laws and regulations in general and specifically observing the electors rights contained in the Accounts and Audit Regulations. In 2018/19 the Council needs to put in place arrangements to ensure that it fully complies with the Accounts and Audit Regulations.

Other matters not affecting our opinion which we draw to the attention of the authority:

The Council was unable to provide the declarations that members signed on acceptance of office due to incomplete records inherited from the previous clerk. The members have signed new declarations in 2019/20. However, we recommend that in future these declarations are kept securely to evidence compliance with laws and regulations.
