According to the Office of National Statistics, the pandemic affected crime patterns and decreases across individual crime types such as theft offences were offset by rises in fraud and computer misuse offences, resulting in no change in overall levels of crime. ## NALC publishes new report on the 2021 local elections

NALC has published its report on the 2021 local (parish and town) council elections.

This report aimed to gather insightful data to provide an overview of the 2021 local elections. This data captured will assist NALC's future campaigns (e.g. <u>Make A Change</u>) and help to shape the range of resources available for local councils and county associations.

The research found that the number of councillors elected through contested elections has significantly increased from 29% in 2019 to 38% in 2021. Despite this positive change, 44% of local councils reported the need to co-opt seats. The data also showed that local councils require further support from county associations and principal authorities in raising awareness of local elections.

Ongoing COVID-19 restrictions hindered local elections in 2021. Broader social contact rules prevented many candidates from campaigning in person and decreased voter turnout in several councils. However, moving to virtual meetings positively affected council meeting attendance, expressions of interest, and council diversity.

The report makes several recommendations to the local council sector and external stakeholders to improve the election process. These include increasing election coverage through regional and national media, working with principal authorities to capture election data, and encouraging people to run for election through talent spotting. NALC commits to providing county associations with access to media training and lobbying the government to simplify and digitalise local council elections.

NALC collected data from councillors, local councils and county associations across England between July and September 2021. The surveys collectively received 1,004 responses. A copy of the full report is attached.

## **Remote meetings**

In a **House of Commons debate** on 24<sup>th</sup> January, the Secretary of State for Levelling Up, Housing and Communities, Michael Gove MP, declared himself to be "strongly in sympathy with the view that hybrid meetings should continue in order to ensure the maximum amount of efficiency". I very much hope this is a positive step forward and we are continuing to urge the government to make permanent the provision for councils at all levels to be allowed to hold remote meetings. This week our chair, Cllr Keith Stevens, was a signatory to a joint letter from several national local government bodies to the opposition parties calling for their support.

NALC is also supporting a **petition** by our colleagues at the Association of Democratic Services Officers (ADSO) and Lawyers in Local Government (LLG) calling on the government and parliament to allow councils in England to have the choice to meet remotely. I'd be grateful if you could support our collective campaign on this important issue by signing the petition and promoting the petition as widely as possible, including on social media.

#### Media coverage

It was good to see BBC Look North cover NALC's opposition to government proposals that will impact the country's burial grounds, including those run by our local councils. We have seen an increase in the volume of spam emails in circulation specifically targeting local councils. Some of these emails purport to come from the chair of the council. Please be careful when opening any emails you receive, an example we have seen is below:

"Could you please spare a minute to assist me in completing a task discreetly. Would be glad to receive your response through email because I'm presently in a meeting.

*Best Regard Cllr X (with the correct name of the chair used but not from their email address)*"

## **Rural Coalition**

NALC's chair, Cllr Keith Stevens, met the rural affairs minister, Lord Benyon, at the meeting of the **Rural Coalition** on 26<sup>th</sup> January, here's a summary:

- The minister indicated that the levelling up white paper was due to be published very soon. He stressed that levelling out was important too – to more remote places to unlock rural potential and support businesses and residents. He was confident the white paper would have a positive impact on rural communities. The Coalition raised concern that the government's plans to achieve net-zero by decarbonising domestic heating could have a disproportionately negative impact on rural areas. We also flagged up the forthcoming publication of a report by the All-Party Parliamentary Group on rural services demonstrating how, for too long, people in rural and coastal areas have experienced poorer access to health and social care.
- There was a discussion on levelling up and devolution which included considering the potential rural implications of the forthcoming white paper, responding as a Coalition when it is published and organising a parliamentary event.
- The Coalition has also agreed to undertake further work on the theme of young people.

## **NALC Policy Committee**

NALC's Policy Committee, which oversees the development and promotion of our policy objectives, met on 25<sup>th</sup> January. In advance of the draft minutes being published here's a summary:

- The Committee endorsed proposals for their work programme which includes reviewing aspects of our policy development and promotion process, responding to the levelling up white paper and a new big theme for this year on planning, housing and neighbourhood planning.
- Councillors were keen to forge a closer working relationship with the Society of Local Council Clerks on policy issues and agreed to invite Shelley Parker, external affairs and policy development manager, to the next meeting.
- They considered policy motions from the Wiltshire Association of Local Councils on urban council gulls, agreeing to make representations to the government on the approval of licenses and to undertake further research; from the Hampshire Association of Local Councils regarding changing councillor numbers through community governance reviews, which wasn't supported; and from the Leicestershire and Rutland Association of Local Council, where they supported measures to ensure compliance of planning applications through building control.



## **Platinum Jubilee Celebrations**

In 2022, Her Majesty the Queen will become the first British monarch to celebrate a Platinum Jubilee and celebrations to mark the Queen's historic 70-year reign will occur throughout the UK and the Commonwealth as part of a year-long programme of events. The Department for Levelling Up, Housing and Communities has asked us to share a letter from the secretary of state, Michael Gove, MP which highlights opportunities for local councils and communities to engage with the Platinum Jubilee – you can read more on this <u>here</u>.

#### **Coastal Communities**
